Subject: ACCOUNTANCY

Read the following hypothetical situation and answer question no. 1-3 Sudha, Naresh and Geeta were partners in a firm sharing profits in the ratio of 5:3:2. Their fixed capitals were ₹6,00,000; ₹4,00,000 and ₹2,00,000 respectively. Besides her capital Geeta had given a loan of ₹75,000 to the firm. Their partnership deed provided for the following: (i) Interest on capital @ 9% p.a. (ii) Interest on partner's drawings @12%. (iii) Salary to Sudha ₹30,000 per month and to Naresh ₹40,000 per quarter. (iv) Interest on Geeta's loan @9% p.a. During the year Sudha withdrew ₹50,000 at the end of each quarter; Naresh withdrew ₹50,000 in the beginning of each half year; Geeta withdrew ₹70,000 at the end of each half year. The profit of the firm for the year ending 31-3-2025 before allowing interest on Geeta's loan was ₹7,06,750.

- 7. On 1st April, 2024, Sameer and Yasmin commenced a business in partnership with their fixed capitals of 15,00,000 and 10,00,000 respectively. They agree to share profits in the ratio of 3:2. The books are closed on March 31, every year. Interest on capitals, salary and commission for partners are allowed even if it involves the firm to incur a loss. Interest on capital is provided @5% p.a. and Interest on drawings is charged @12% p.a.

- 9. Krishna, Sandeep and Karim are partners sharing profits in the ratio of 3:2:1. Their fixed capitals are: Krishna 1,20,000, Sandeep 90,000 and Karim 60,000. For the year 2024-25, interest was credited to them @6% p.a. instead of 5% p.a. Record adjustment entry. Show your workings clearly.
- 10. On 01.07.2024, Ravi, Kavi and Avi started a partnership firm with fixed capitals of ₹6,00,000, ₹6,00,000 and ₹3,00,000 respectively. They decided to share profits and losses in the ratio of their capitals. The partnership deed provided for the following: (i) Interest on capital @10% p.a., Interest on drawings @12% p.a. (ii) A monthly of ₹10,000 to Avi. (iii) Ravi was guaranteed a minimum profit of ₹50,000 p.a. On 1.10.2024 Kavi was in need of funds due to his daughter's marriage, so he took a loan of ₹50,000 form the firm at an agreed rate of interest being 10% p.a. The net profit of the firm for the year ending on 31.03.2025 was ₹3,05,500 before charging interest on loan to Kavi. Interest on partner's drawings was Ravi ₹4,800, Kavi ₹4,200 and Avi ₹3,000. Profit and Loss Appropriation Account of Ravi, Kavi and Avi for the year ending on 31.03.2025.

Subject: BUSSINESS STUDIES

1. Smita Rai is the director of Namchi Designer Candles, which has 100 percent women as employees. They also produce varieties of candles. During Diwali, they produce customized candles meant for the occasion. Smita plans her Diwali collection in the monthj of June itself. She has to then ensure that there is an adequate workforce and continuously monitors whether production is proceeding according to plans. Her marketing department also has to be briefed in time to prepare their promotional and advertising campaigns.

At Namchi Designer Candles, the production and sales department coordinate their work, so that production takes place according to the demand in the market.

The purchase, production and sales departmental efforts have to be coordinated by Smita for achieving organizational objectives harmoniously. The purchase department is responsible for procuring fabric. This then becomes the basis for the activities of the production department and finally sales can take place. If fabric purchased is of an inferior quality or is not according to the specifications of the production department, further sales will also decline. Identify and explain by quoting lines from the above the three characteristics of coordination.

- 2. Pallavi started a wedding planner company 'Dreams Unlimited' in 2016 and her target was to be amongst the top 10 companies in the field within the next three years. For this she employed people having different skills. She worked hard and united the efforts of different people to achieve this goal. As planned, the company achieved its target within three years. All the employees of the organization were happy and satisfied and the effect of management was noticeable in the organization. He said that he believed that a good company should have an employee suggestion system and he wished to minimize employee turnover to maintain organizational efficiency. He informed all employees that he would ensure that all agreements were clear, fair and there was a judicious application of penalties. However, he said that he believed that lazy personnel should be dealt with sternly to send the message that everyone was equal in the eyes of management. Also, that he would want to promote team spirit of unity and harmony among employees, which would give rise to a spirit of mutual trust and belongingness among team members and eventually minimize a need for using penalties. He told all present that the interests of the organization should take priority over the interests of any one individual employee.

5. Sanchit, after completing his entrepreneurship course from Sweden returned to India and started a coffee shop 'Aroma Coffee Can' in a famous mall in New Delhi. The specialty of the coffee shop was the special aroma of coffee and a wide variety of flavours to choose from. Somehow, the business was neither profitable nor popular. Sanchit was keen to find out the reason. He appointed Sandhya, an MBA from a reputed college, as a manager to find out the causes of the same. Sandhya took feedback from the clients and found out that though they loved the special unique aroma of coffee, they were not happy with the long waiting time being taken to process the order. She analysed and found out that there were many unnecessary obstructions in between which could be eliminated. She fixed a standard time for processing the order.

She also realized that there were some flavours whose demand was not enough. So, she also decided to stop the sale of such flavours. As a result within a short period Sandhya was able to attract the customers.
